

## Ongoing Research at CEGESOMA

The research conducted at CEGESOMA is twofold: on the one hand there is the research carried out by the permanent researchers and on the other the research projects which are limited in time and are funded with exterior resources, for the most part by the Belgian Federal Science Policy Office (see Scientific team). These research activities and projects are in the field of 20th century history and principally concern the two world wars.

Current research projects are:

- Two BRAIN projects (Belgian Research Action through Interdisciplinary Networks, Federal Science Policy) on the First World War. The first, led by Karla Vanraepenbusch, lists and analyses all the memorial traces of the Great War in the urban landscapes of Antwerp and Liège. The second, led by Florent Verfaillie, studies the social impact of the war on the members of the resistance and collaborators of the First World War.

## New call to families in the context of the Transmemo project

The Transmemo project is a federal and interdisciplinary research project on family memory of the resistance and the collaboration in Belgium during the Second World War.

CegeSoma participates in this project in partnership with a team of historians of Ghent University and a team of social and cognitive psychologists of the *UCL (UniversitÃ© catholique de Louvain)*.

The project was launched in October 2017 and dozens of Dutch- and French-speaking families have already been interviewed.

## **CegeSoma is looking for families who want to participate in a new research project on family memories of resistance and collaboration**

In the context of the latest project on family memories of resistance and collaboration in Belgium, which CegeSoma has started in cooperation with Ghent University and the UCL, we are looking for families who are willing to share their family history and their war memories.

## **The results of the MADDLAIN project**

After two years, the MADDLAIN project has come to an end. Six researchers have analysed a large number of data, including the results of a survey answered by 2,300 external users. Additionally, numerous interviews have been examined. Today, the three associated institutions behind MADDLAIN – the Belgian State Archives, the Belgian Royal Library, and CegeSoma – are happy to present the results of their investigation.

On Friday the 22nd of September, the final results of the Interuniversity Attraction Pools (IAP's) Justice & Society and Justice & Population were festively presented in the Palace of Academies in Brussels. ## **TRANSMEMO: New Research on the Memory of Collaboration and Resistance during the Second World War**

In September 2017, the new research project TRANSMEMO has been launched, a partnership between the CegeSoma (Nico Wouters), Ghent University (Bruno De Wever & Koen Aerts) and the UCL (Olivier Luminet & Valérie Rosoux). Three young researchers, Florence Rasmont (CegeSoma), Aline Cordonnier (UCL) and Pierre Bouchat (UCL) are in charge of the project.

## **ARCHIVES – UGESCO Project : High-quality Spatial-temporal Metadata for the Digitized Collections**

The UGESCO project was launched on 1 April. It is a two-year project coordinated by the ELIS department of Ghent University, with the participation of CegeSoma (Belgian State Archives), the STIC department of the Université Libre de Bruxelles, the Arts Faculty of the University of Leuven and the Geography department of Ghent University.

## **MADDLAIN - Highlights of the Study Day Inside the User's™ Mind**

On 22 February 2017, the conference room in the Royal Library in Brussels was packed. Some 200 amateur and professional researchers, in charge of digitization in a heritage institution, archivists or curators of collections, were present to hear the results of the MADDLAIN research project which was carried out for two years by CegeSoma (OD4 – State Archives), the State Archives and the Royal Library. The goal? A better understanding of the practices and digital needs of their different audiences and users with the aim of developing new strategies.

## **IAP Project – Murders during the Liberation and the Belgian Judiciary: the Case of Brussels – Multiform violence against collaborators**

Everywhere in Europe, governments and citizens dealt with collaborators after the liberation in 1944-1945. This was done through legal institutional means by courts, but also in a more spontaneous and violent ways by members of resistance groups and citizens. In Belgium as well, real and alleged collaborators were taken prisoner, molested and in some cases murdered. There was also more symbolic violence: household goods were destroyed and homes were plastered with slogans. This street violence was a reaction against the many years of occupation, but it is today, and in some cases also at the time, considered unjust (and illegal).

## **ADOCHS - For a better quality of the digitized collections**

On November 1st 2016 the CegeSoma launches the ADOCHS project (Auditing Digitalization Outputs in the Cultural Heritage Sector) in collaboration with the Royal Library of Belgium (*KBR*), *VUB* and *ULB*. This project is dedicated to the improvement of the quality control process concerning the digitized heritage collections. On the basis of written and iconographic sources, the team will develop methodological and technical tools needed to guarantee a control of the quality of the technical aspects and of the quality of the metadata. ## **BRAIN – Two Research Projects on the First World War The Social Impact of the War on Members of the Resistance and Collaborators & Memorial Traces of 14-18 Liège and Antwerp**

Within the framework of the BRAIN programme (/Belgian Research Action through Interdisciplinary Networks/, Federal Science Policy), Karla Vanraepenbusch and Florent Verfaillie started in March 2014 their PhD research on the First World War. Through these research projects, CegeSoma holds an essential place in the field of new fundamental WWI-research in Belgium.
